Meeting was called to order by President Mulcahy at 8:08 a.m.

- 1. September minutes were reviewed. A motion was made by Jamie Sizelove to approve. Second by Sara Rivas. Unanimously approved.
- 2. President Mulcahy reviewed the September minutes and made the Board aware that a dentist in the CBID, Dr. Alan Robb filed a claim in Small Claims Court regarding Universal Site Services not providing the services expected. This is being addressed. A motion was made by Steve Sibley to approve. Second by Kathleen Erdmann. Unanimously approved.
- 3. Treasurer's Report: President Mulcahy reviewed the report. (a). BBQ in the Glen next month we should be able to report a recap. (b). 190K in the general account, 38K in the Foundation Account. (c) A discussion ensued on how funds in the Foundation Account will be used. There were questions on the report which will require further discussion. A motion was made for a 'soft approval' by Emilie Highley. Second by Jamie Sizelove. Unanimously approved.
- 4. Member Relations (Staff): (a). Beautify San Jose beautifysj@sanjoseca.gov is an initiative to clean up and restore our community, i.e. encampments. The City of San Jose is committed to supporting the community. There are Grant Program funds for beautification projects, clean-up efforts, etc. Suggestion made for WGNA & WGBA to form an alliance to act

on encampments – even contact our Mayor to have him walk through these areas. (b). There is a Haunted House on Almaden Expressway & Bryant. The rep would like to meet with Kendra on how the WGBA could get involved. (c) Kendra will be meeting with Nicolas from Councilmember Davis' office to discuss lighting & safety enhancements, Uber & DoorDash drivers double parking issues.

- 5. CBID: Meeting scheduled for this week. More updates in next month's meeting.
- 6. Our Avenue: Kathleen reported (a) Jamie & Brian has put up new some lights on the Urban Republic Building for the Board to observe. (b) Universal Site Services Kathleen plans to walk the Avenue with the previous manager and spend time with the new manager. Universal is now providing weekly reports. A discussion ensued with Universal regarding the claim that Dr. Robb has made.
- 7. P&E: Emilie reported (a). BBQ in the Glen very successful event and well attended by the Community. Good reviews on the food, music, kids jumpy house, attendance by the Shark's. Hope to have a wrap up by next Board Meeting. (b) Plans in place for the Wine Walk. Campbell is having their OctoberFest the same weekend. (c) Halloween Councilmember Davis is giving the WGBA \$500 (past years it has been \$1000). \$500 will not buy enough candy to support all the children and parents that are expected. Staff will purchase at least another \$500 in candy.

Board Recruitment

The board discussed recruiting new members for the new year. There are several open positions and the nominating committee will approach some new business owners, hoping to have new members participate in meetings and events. This will begin after Halloween.

BBQ Wrap up

The receipts from the BBQ have not been settled yet so the final numbers were not available. There was much discussion about the BBQ.

Fall Wine Walk

Approximately 400 attendees participated in the Fall Wine Walk. Low turnout was attributed to competition from Campbell's 2 day Octoberfest event.

Eventbrite— Eventbrite offered \$10k for settling the dispute for the cable car tickets last year and WGBA accepted. Emilie questions the timing of the deposit, hoping it will be sooner rather than later.

CBID – Tim Mulcahy, Nate Perez, Kendra Middendorf and Kathleen Erdmann met with Kristen and Nancy regarding the CBID meetings wrap up. The full service now provided to Zone 1 will extend through the expansion. This will increase the price for Zone 2 and the expansion but give all properties the same level of service, giving the Avenue a consistent level of service and overall improvement. We now have a list of the largest property owners.

Staff Reported

- Endsight Jessica asked about the status on entering into a contract with Endsight. The E Board said we are not in a position to make this commitment at this time.
- **Dancing BBQ** Staff suggested we discuss a different approach to the BBQ and will work on a model that includes dancing and a BBQ with just a few grillers who pay for their own booth and meat. There was much discussion around this proposal need more information to even discuss further.
- Alex Shoor is running for council and would like to speak at a board meeting. The board suggested that each candidate would need to speak.

The next board meeting will be November 14th at 8 a.m. at the Conference Room in the Garden Theater.
